APPLICATION METHODS

Static waterbody

- Distribute packets evenly over water surface.
- Distribute packets around edges in shallow, warm water areas.

Flowing waterbody

- Apply at point(s) of water entry.

In order to determine dose rates

Calculate the volume of your pond in acre feet:

$$\frac{\text{Length} \times \text{Width} \times \text{Average depth}}{43,560} = \text{Acre feet}$$

To initiate the treatment program, apply three pounds (6 packets) of Revive per acre foot. For best results, water should be at least 60°F and have pH of 6.8 - 8.8.

Maintain with additions of one pound (2 packets) per acre foot at 2-week intervals.

More frequent applications are recommended during periods of stress, such as heavy rainfall, drought, excessive heat or fertilizer run-off.
